Jenner's Pond receives Pennsylvania assisted living licensure
West Grove retirement community one of the first in the Commonwealth

West Grove, Pa. (October 27, 2011)—[Jenner's Pond](#) received its assisted living residence (ALR) licensure in early July from the [Pennsylvania Department of Aging, Office of Long-Term Living](#). Jenner's Pond received its licensure after an in-depth application and inspection process conducted over the course of several months. As of now, the community is one of only eight in the state to receive this licensure.

The Commonwealth of Pennsylvania established this [licensure](#) earlier this year to allow people to “age in place.” This means an ALR must accommodate a resident’s care and service needs as they increase without having the resident move to a higher care setting. The standards, therefore, are higher than previous regulations and cover such provisions as staffing, square footage of residences, as well as training. Each of these aspects is important to accommodate changing needs while ensuring continued resident independence.

“Our culture here at Jenner’s Pond has always been one of encouraging independence, choice and assisting residents to live to their maximum potential,” says Linda Wilmot, Senior Administrator at Jenner’s Pond. “In this respect, the new [licensure](#) is a perfect fit with our mission and philosophy.”

During the application process that began in April, Jenner’s Pond provided detailed information regarding staffing, policies, training and physical layout, as well as demonstrated familiarity with the new regulations. The Office of Long-Term Living conducted two inspections—one scheduled and one unannounced—of the [Ruston Residence](#), Jenner’s Pond’s assisted living area.
